List of accessible sources / studie and a cloud folder filled with the reference documents useful to DW Akademie. / Data file with the most relevant data on freedom on expression, access to media and technology. Requirements: The applicants shall have (a) in-depth knowledge of the media landscape of EA; (b) excellent analytical skills and attention to detail in documenting the findings; (c) excellent English language skills in written and verbal form; and (d) communicate well with the project team in KE and GER.
